  - a. Joe will schedule a meeting with non-profit TV rep for February 8 meeting.
3. Number of teams for the upcoming 2010 season.
  - a. Mets – same, solid
  - b. Orioles – Dave Roberts potentially taking over. May take most of former Bison team with him. Dave potentially has 6 other players to bring on board.
  - c. A's – currently working with Anthony Mayo to rebuild the team. Management structure to still be decided. Anthony's father may put a team in 30+ league. Sam Lebeau may also be a potential to take over team as well.
  - d. Pirates – core of team will return.
  - e. Bison – Donny would like to take a year off from managing.
  - f. Cardinals - Old Orioles team.
  - g. Tigers (Bison)? - Lance- drawing on Bison and Yankees. (Maurice and brother)
4. The addition of a 30+ (MSBL) Division to our league.
  - a. Sundays only- 7 inning games.
  - b. Understand desire to have 30+ league abide by all rules and regulations of Charlottesville MABL.
  - c. Deposit due on same day \$550. Balance of \$1,400 will be due by April 12 meeting.
5. Work on our 2010 budget.
  - a. Based on current assumptions, including TV advertisement; budget shaping up to be approximately \$3,150 per team for six teams.
